

Heb 5:1 For every Kohen HaGadol taken from among men is appointed for men in things pertaining to vuvh, that he may offer both gifts and sacrifices for sins: 2 He is the one who can humble himself.

Four prerequisites for the priesthood:

- I. He must be taken from among men (meaning he abode amongst humanity, yet not from humanities origins - dust. He's not an angel, He's not a ghost but was amongst humanity in the flesh)
- II. He must be able to offer gifts and sacrifice (Acts 2:38 *Then Peter said unto them, Repent, and be immersed every one of you in the name of Yahusha Messiah for the remission of sins, and ye shall receive the gift of Ruah Ha Kodesh*) In reality this speaks of the blood offering and the meal offerings. Moshiach's sacrifice is the blood offering the Ruach Ha Kodesh is holy sustenance for the believer - the meal offering.
- III. He must be able to sympathize, He must be compassionate as one who has experienced infirmity. He deals gently, GK: *"to suffer without harshness."* To be in the middle of something, or to bring moderation and balance by being fully involved. Yahusha avoids the twin extremes of apathy and excessive feelings.
- IV. He must be appointed by יהוה - unlike the previous 240 year history of our audience

5:2 and have rachamim on the ignorant and erring*; for that he himself also is surrounded with weaknesses. (These words* parallel those of King David in Ps. 119:176, *"I have gone astray like a lost sheep, seek your servant, for I do not forget your commandments."*) Ignorance is a source of sin, there are sins of ignorance. Erring is the result of sin. As High Priest He must deal gently and bring balance. Unlike the Levitical High Priest He doesn't have the disadvantage of having to offer sacrifices of his own sins. While the earthly Levitical priest was in sin and had to obtain purity, the Heavenly High Priest has no sin and is thus always has purity.

By the 1st Century the position of the high priesthood had been defiled and degraded. The Second Temple period was the age of wrath with preposterous priests occupying the priesthood.

This account from the annals of history:

"Once on the Feast of Tabernacles, the populace pelted the high priest with citrons because he insisted on performing the water libation ceremony in a way which didn't commend itself to them as proper, he poured the water on the ground beside the altar, after the Sadducean manner and not on the altar itself, in the Pharisaic manner."

There were murders, assassinations and trickery throughout the Hasmonean period, in fact all the way up to the destruction of the Temple 240 years later.

HP History: after the disposition of Onias III in 174 BCE, Jason and later Menelaus were appointed to the high priesthood by Antiochus IV, Alcimus was appointed by Demetrius I in 162BCE, the Hasmonean Jonathan was appointed by Alexander Balas, putative son of Antiochus IV, in 152 BCE, his brother Simon and his successors were

appointed by decree of the Jewish people in 140 BCE (1 Mac 14:41). With the fall of the Hasmonean dynasty the high priests were appointed successively by Herod the Great (37-4BCE), Archelaus (4BCE-6CE), Roman governors (6CE-41) and members of the Herod family (41-66CE). The last high priest, Phanni, son of Samuel, was appointed by popular ballot during the war against Rome.

In the Qumran commentaries the holder of the Hasmonean high priesthood is referred to as the '*wicked priest*.'

The Greek word in V.2, '*agnoousin kai planomenois*' '*ignorant and erring*' has in mind the history of the line of corrupt high priests that besmirched the priesthood.

War between royal bloodlines for the priesthood - Yeshua - the Davidic Vs the Pharaohs of the 18th Dynasty and later the Hasmoneans all the way into our present presidential candidates - 2016 is going to be a crazy year..... if you're paying attention!

What happened to the Pharaohs? They migrated to Europe then through Christopher Columbus to the USA, *the Pharaonic bloodline rules today*. (King Tut's father/ Akhenaten, his daughters and Queen Tiye)

The Pharaoh's really believed they'd live again!

Who knew it would be through bloodline preservation and 1950's & 1960's DNA work on Egyptian Mummies, which would make the test tube babies to be in their 50's and 60's - the ruling elite!

The bloodline of Rameses II (1295-1228 BC), who was considered to be the greatest pharaoh of all.

He was his country's master architect, sacred geometry and his name can be found on almost every ancient shrine. The gold mines of Nubia made him rich beyond the imagination. This bloodline also includes the demonic human hybrids who ruled *sumer Babylon, Greece, and Troy*, and which, today, rule the world

This key bloodline comes down through the most famous Egyptian queen, Cleopatra and is connected to the Hebrew-Egyptian royal bloodline. (60-30BC), who's lover was the most famous Roman Emperor, Julius Caesar, and bore him a son, who became Ptolemy XIV.

- She also bore twins with Mark Anthony, who has his own connections to this line and its many offshoots
- This bloodline also connects to Herod the Great, the "Herod" and continues to the Roman Piso family.
- The same bloodline includes Constantine the Great, the Roman Emperor who, in 325AD, turned Christianity, based on his ancestors' stories, into the religion we know today

- King Ferdinand of Spain and Queen Isabella of Castile, the sponsors of Christopher Columbus who instigated the *Spanish Inquisition* (1478-1834)
- the most used version of the Bible was commissioned and sponsored by another strand in the same bloodline, King James 1st of England.

The line of James, according to genealogy sources can be traced back to 1550 BC and beyond and includes many Egyptian pharaohs, including *Rameses II*.

The bloodline moved into France and northern Europe through *the Franks* and *Meroveus or Merovee*, who gave his name to *the Merovingian bloodline*, and it continues with the rest of the Merovingian clan like Clovis and the Dagoberts who connect into the elite secret society, *the Priory of Sion* and the Rennes le Chateua mystery in Languedoc.

From *the Merovingians*, this bloodline's connections to the present day include: Charlemagne (742-814), who ruled as Emperor of the West in the Holy Roman Empire; a stream of French kings, including Robert II, Philip Ist, II and III, and Louis Ist, II, VI, VII, VIII, VIII, XIII, IX, XV, and XVI.

The latter married Marie Antoinette of this same bloodline and both were executed in the French Revolution. But they produced the son who became Daniel Payseur, who was taken to the United States where he became the secret force behind *the Morgan and Carnegie empires* and owned vast amounts of real estate, banking, and industrial holdings.

This bloodline also connects to the *de Medici family* which supported Christopher Columbus and produced Catherine de Medici, the Queen of France who died in 1589. Her doctor was Nostradamus: It includes Rene d'Anjou, Duke of Lorraine, and the House of Lorraine which employed Nostradamus and Christopher Columbus.

The bloodline relatives of the de Medicis and the House of Lorraine, Queen Isabella of Castile and King Ferdinand of Spain, were also sponsors of Columbus when he discovered the Americas.

This bloodline also includes:

1. the Habsburg's, the most powerful family in Europe under the Holy Roman Empire
2. Geoffrey Plantagenet and the Plantagenet royal dynasty in England
3. King John, who signed the Magna Carta
4. King Henry Ist, II, and III, who were extremely close to the Knights Templar, as was King John
5. Mary Stuart and the Stuart Dynasty, including King James Ist of England, sponsor of the King James version of the Bible
6. King George Ist, II, and III
7. Edward Ist, II, and III, Queen Victoria

8. Edward VII
9. George V and VI
10. Queen Elizabeth II
11. Prince Charles and Elizabeth's other offspring, Anne, Andrew and Edward
12. Princes William and Harry from Charles' "marriage" to Princess Diana
13. US Presidents, George Washington, John Adams, John Quincy Adams, Thomas Jefferson, Franklin Delano Roosevelt, and George Bush *are all named in the charts as strands of this bloodline*
14. it was passed on to the year 2000 US presidential favorite, George W. Bush Jr., and his brother, Jeb Bush.

In fact if you go deeply enough into the genealogical research you will find that *ALL the presidents are from this line.*

Genealogical sources, like the New England Historical Genealogical Society and Burkes Peerage, have shown that 33 of the 42 presidents to Clinton are related to Charlemagne and 19 are related to England's Edward III, both of whom are of this bloodline which connects all the way back to the 18th Dynasty.

US debt crisis endebts us to The Rothschilds who funded the 3rd Reich and are now funding and in the final phase of establishing the 4th Reich. The Rothschild's funded Hitler through the Bank of England. The heart of the war machine of Hitler was the chemical giant IG Farben, which had a division in America that was controlled by the Rothschilds. Hitler's IG Farben, ran Auschwitz, and was a division of Standard Oil, officially owned by the Rockefellers.

The victors write history. Finally history is being rewritten - Hitler and Eva Braun didn't die in Furherbunker in Berlin April 27 1945. Hitler died Feb 13, 1962 in a small valley village in remote Argentina. A trade with the **Royals** for all the booty of war hidden throughout Europe!

The British Royal family that helped create Hitler's Nazi regime. The British started secretly funding the National Socialist German Workers' Party, through Britain's Lord Norman and Germany's former Reichsbank president Hjalmar Schacht, who got eventual backing of all of the major industrialists in Germany. The highest levels of British society secretly backed Hitler including Neville "Peace in our time" Chamberlin, British press magnate Lord Beaverbrook, Governor of the Bank of England Montagu Norman and most notably King Edward VIII.

Adolf's father, Alois Hitler, was the illegitimate son of Maria Anna Schicklgruber. It was '*generally supposed*' the father of Alois Hitler (Schicklgruber) was Johann Georg Hiedler. But Maria Anna Schicklgruber lived in Vienna when she conceived. At that time she was employed as a maid in the house of Baron Rothschild. Once the family discovered her pregnancy, she was back home ... where Alois was born." Baron De Rothschild was Hitler's Grandad! But Hitler not only lead the Reich in World War II he was a foot soldier in Edwards war, WWI!

King Edward VII was in the pay of the Rothschilds and was responsible for World War One.

Nathan Rothschild. *"I care not what puppet is placed upon the throne of England to rule the Empire on which the sun never sets. The man who controls Britain's money supply controls the British Empire, and I control the British money supply".*

Queen Victoria, Edwards mother had children with Lionel de Rothschild and two of Edward's sisters, Helena and Beatrice, were Rothschilds. The British Royal family is "a biological, financial and moral subset of the Rothschild international bankers" that was at war against the Americas colonialists and is still at war against bible believing American patriots!

Edward VII was the mentally deficient product of the marriage between Queen Victoria and her first cousin Albert. He had many children, his eldest son, Clarence, was so mentally deranged that he was the prime suspect in the Jack the Ripper murders. Edward VII had dozens of mistresses, One of these was the Jewish-born Lady Randolph Jennie Jerome Churchill. Edward VII was **Winston Churchill's** real father Churchill was a Ashkenazi Jewish aristocrat.

Fast forward, Princess Diana was Ashkenazi. Diana's mother was Frances Shand Kydd born Frances Ruth Burke Roche - Rothschild she had relationships with a Jewish banker called James Goldsmith while she was married to Earl John Spencer. Diana was born in 1961 and was the illegitimate child of Goldsmith and was not the real daughter of Spencer. So Harry and William are also Ashkenaz!

Kate Middleton's mother was surnamed GOLDSMITH!!! before marrying Kate's father.

Anyway **Kate and William** were already family before the married going back to 1576 with Sir Thomas Leighton and Elizabeth Knollys.

Why is this important and what does any of this have to do with Hebrews Chapter 5?

Rabbi Richman and rabbi Glick, the general director of The Temple Institute in Jerusalem have announced the completion of the Tzitz, the High Priest's head plate - now ready for use in the NWO temple. By Illumianti rights William with both the lineage and the throne has the rights to be their King Priest of Jerusalem.

Matt 11:12 And from the days of John the Baptist until now the kingdom of heaven suffereth violence(Parats), and the violent take it by force.

Heb 5:3 And because of these he is obliged, to sacrifice for the people, and also for himself, on account of his own sins. 4 And no man takes this honor to himself, but he that is called of vuvh, as was Aharon. 5 So also the Moshiaich esteemed not Himself to be made a Kohen Gadol; but He that said to Him, You are My Son, today have I brought You forth.

From Ps. 2:7, “today” our author has in mind Moshiach’s enthronement, the day when the Most High gave public notice that he had exalted the MalkiTzedik as “both Master and Messiah” (Acts 2:36). He is both Davidic Messiah (Ps.2) and High Priest (Ps.110).

5:6 As He says also in another place, You are a Kohen le-olam-va-ed after the order of Malki-Tzedek. ,

What many fail to realize is that after King David claimed Jerusalem (Shalem) as his capital, (2 Sam 5:6) he and his descendants after him received the priestly duties of Malki-Tzedik as their own to guard until the time of Yahusha.

2 Sam 8:18 *‘Benaiah the son of Jehoiada was over the Cherethites and the Pelethites, and Davids sons were chief priests-kohanin כהנים’.* David and his heirs became guardian’s to Malki-Tzedik’s kingship and priesthood and traditions in lieu of Yahusha’s re-ratification of it.

The Qumran community had an ever present expectation of in both a lay and kingly messiah. In the Testament of the Twelve Patriarchs we see this evidenced.

1QS 9:10 *“They shall depart none from the counsels of the Law to walk in all the stubbornness of their hearts, but shall be ruled by the primitive precepts in which the men of the Community were first instructed until there shall come the Prophet and the Messiahs of Aaron and Israel.”*

During the war of liberation led by false messiah Shimeon Bar Kochba 132-135CE coinage had the ‘king’ Kochba on one side and ‘Eliazer the priest’ is on the other. This drives home the expectation of king and priest, yet still many were unable to realize that the key is that the roles of Aaron and Israel were fulfilled in one person - Yahusha the MalkiTzedik so they were deceived and slaughtered. It won’t be any different inner day!

We have men who aren’t qualified stating by false genealogy and Levitical hierachy that they’re the enlightened ones on the Levitical priesthood, when in reality יהוה has enlightened His people together as ‘echad’ in the priesthood of a different order. Remember, it was not only the Pharisees but the chief priests and scribes, those of the party of the Sadducees that were the principal critics of Yahusha.

The reality is Yahusha now fills a role that in his time was often occupied by those who were inept, incomplete and downright wicked.

What a contrast our author is painting with Yahusha to the high priests of the 1st Century.

Yahusha’s priesthood had a precedent established prior to the founding of Israel as a nation and is therefore the higher and more ancient priesthood. His priesthood goes beyond the Levitical priesthood, his personal death goes beyond the sacrificial system and his risen body builds a better temple!

5:7 Who in the days of His flesh, when He had offered up tefillot and supplications with strong crying and tears to Him that was able to save Him from death, and was heard.

This speaks of Gethsemane, Mark tells us that, “horror and dismay came over him”, Yahusha said to the talmudim, “my heart is ready to break with grief, stop here and stay awake.”

LK 22:44 And being in an agony he prayed more earnestly: and his sweat was as it were great drops of blood falling down to the ground.

Mk 14:33 And He took with Him Kepha and Yaakov and Yochanan, and He began to be very pressed down, and to be deeply distressed; 34 And said to them, My being is exceedingly sorrowful to death: tarry here, and watch. 35 And He went forward a little, and fell on the ground, and made tefillah that, if it were possible, the hour might pass from Him. 36 And He said, Abba, Abba, all things are possible for You; take away this cup from Me: nevertheless not what I will, but what You will.

What many fail to realize is that this doesn't refer to Yahusha trying to get out of the crucifixion as Christian commentators explain, that was another cup, the cup which he warned James and John they would also have to drink of if they wanted to share His glory (Mk 10:38). No, this speaks of the cup of “sorrowful death” our master prayed in Gethsemane that he might be saved from dying there and then, through physical exhaustion and satanic assault. The cup He prayed to be delivered from was not the death on the tree, not for grace to escape it! Had he died in the Garden, no greater calamity could possibly befall on mankind. The offering up of his life, “not my will but yours” was the “ransom for many” established from the foundation of the earth! SELAH!

5:8 Though He was The Son, yet He learned obedience by the things that He suffered; 9 And He grew to be perfect, and He became the author of eternal salvation to all them that obey Him; 10 Called of vuvh a Kohen HaGadol after the order of Malki-Tzedek. 11 About whom we have many things to say, but some are hard to explain, seeing you are dull of hearing. 12 For when by this time you ought to be morim, you have the need that someone teach you again the first principles of the primary writings of vuvh; 6 and have become those that need milk, and not strong meat. 13 For everyone that uses milk is unskilled in the word of tzedakah: for he is a baby. 14 But strong meat belongs to them that are mature, even those who by reason of using the word, have their senses exercised to discern both tov and evil.

The contrast between milk and meat was commonplace in Greek moral philosophy of the day (1 Cor. 3:1). Today's American Church subsists the most part on milk - teaching elementary Christian ethics where the worldly spirit of syncretism, is accepted as part of

Western society as a whole. In reality it's little different from the YMCA. They must be treated as spiritual infants because they're unable to assimilate the spiritual meat because of the anchor of carnality they're dragging through their life. Shabbat, the Feast of יהוה , the dietary commandments and the call to everything Malki-Tzedik are spiritual disciplines that force you to bury the flesh.

You must leave babyhood and milk and press onto meat and maturity. The danger is that if you don't you'll make an irreversible decision that will permanently keep you in a state of spiritual immaturity.

What can't go unnoticed is this phrases association with Corinth and Apollos's association with Corinth! Peter picks up on this phrase in 1 Pet 2:2 in regards to our inner soul health - who we are - our very essence is dependent on pressing onto the meat of word and doctrine.

The statement that the recipients of this letter ought by now to have qualified as teachers of others gives me cause to identify them with the converted Levitical priests of Acts 6:7 - the idea that converted neophytes would be expected to become teachers seems quite implausible.
